Message From the Founder

The first half of 2013 demonstrated continued growth in transplants facilitated with a 48% increase in volume over the same period last year. Transplants facilitated in the first half of 2013 rose to 144 which is an increase of 47 over the first half of last year. This brings us to 759 transplants since we started organizing swaps in 2008.

The average wait time for enrolled patients dropped approximately 20%, from 1.1 years in the prior quarter to 0.9 years in

the current quarter. This significant reduction in patient wait time was driven by two factors, software enhancements made to the matching engine and a new match offer selection policy adopted by our Medical Board. These improvements also allowed us to match many more highly sensitized patients. In the first half of this year 34% of the transplanted patients had a cPRA > 80% compared to 23% during the same period last year.

This quarter we also saw a reduction in the number of swaps cancelled which we attribute to an intensified focus on the collection and analysis of root cause and corrective action plans whenever swaps fail. The conversion rate from match acceptance to transplant increased from 26% to 31%, quarter over quarter. We hope this trend continues as our member centers fine tune their internal processes to eliminate preventable swap failures, thereby improving the reliability of our service to patients in need of a transplant.

None of this success would be possible without the effort and dedication of the medical professionals at our Member Centers. Thank you - and keep up the great work.






Process Volume






Swap Failures by Primary Root Cause

As of 6/30/2013









Patients Waiting > 1 Year by cPRA


Patients Waiting > 1 Year by Center










New Pair Registrations Per Month









2013 Transplants by Wait Time

90% of transplanted patients waited < 12 months










Transplanted Patient Average Wait Time

The average of the actual wait times of patients transplanted during the year







Transplanted Patients by Year by cPRA









Average cPRA of Transplanted Patients by Year






Pool Composition by cPRA
